The meeting was started with the welcome of all the members by the Prin. Dr. V. S. Shivankar which was followed by the agenda reading by Dr. S. S. Nayak

#### Reading of Agenda:

Motion from Dr. S. S. Nayak: To approve the agenda for 19<sup>th</sup> October 2018.

Vote: All in favor.

Resolved: Motion carried.

Agenda for the meeting on 19th October 2018 approved without modification.

#### **Business:**

1. Motion 1: Approval of curricula of various Core Courses.

Description: The College offers 15 undergraduate [UG] courses, 11 post-graduate [PG] courses, 01 PG Diploma and has 04 research centers offering doctoral degree. In the current

academic year 2018-19, the curricula of First Year UG and First Year PG are redesigned. The curricula were presented to the respective Boards of Studies [BoS] in the meetings held in the months of July and August 2018. After making the changes as per the suggestions given by the BoS, the final drafts were presented to the Academic Council in a meeting held on 1st September 2018. After the approval of the AC, the curricula are uploaded on the institutional website.

**Discussion:** Dr. Vijay Joshi suggested that changes in the syllabus along with the justification is to be sent to the governing body prior to every meeting for the review and accordingly documentation is to be done. Before sending the syllabus to BOS for approval, parents opinion should also be considered.

The members approved the suggestion.

## 2. Motion 2: Approval of curricula of various Skill Based Courses.

**Description:** The college offers 36 Skill Based Courses across faculties. These courses are of 1 or 2 credit each. The curricula of these courses are approved by both Board of Studies and Academic Council. The experts are invited from the respective areas to conduct these courses. **Discussion:** Publicity of the skill based courses is to be done so that more students will be attracted towards the courses (e.g. Data Analysis, Biostatistics, Tally)

## 3. Motion 3: Approval of Evaluation System.

**Description:** The college has set up an Examination Committee as per the UGC norms that functions to conduct all examinations in the college and handles all matters related to it. Additionally, the college has established a Board of Examination having Director of Examination and Evaluation, University of Mumbai as an invited expert. All the examination and evaluation reforms are approved by BoS, Academic Council and Board of Examination.

**Discussion:** Evaluation pattern and Rubrics for each evaluation method was discussed.

M.A. [Geography], M.A. [Psychology], B.A. [Philosophy] and NCC as an elective course will be started from the next academic year i.e. 2019-20. The permissions are sought from the Rayat Shikshan Sanstha as well as the University of Mumbai.

**Discussion:** Dr. V. S. Negi suggested that GIS is to be embedded in Geography PG programe.

#### **Action Taken Report**

- As per the suggestions of this esteemed Governing Body, feedback on curricula is taken from students, teachers, alumni, employers as well as parents. The feedback link is provided on the institutional website. A zip folder of all curricula is sent to all the members of Governing Body prior to the meeting on 16/03/2019.
- 2. The evaluation system introduced at the college is composed of Continuous Internal Evaluation [CIA] (40%) and Semester End Examination [SEE] (60%). The question papers for semester end examination were set by external subject experts. Also, moderation of the answer papers was done by external subject experts, while the assessment of answer papers was done by the faculty members of the department. An Open Day was organized for the student- teacher interaction to resolve queries related to the examinations conducted. Internal examination Test of 20 marks was conducted as an online test.
- Local Inquiry Committee of University of Mumbai visited this college on 27<sup>th</sup>
  February 2019. Following courses will be started from academic year 2019-20.
  - o M. A. in Geography
  - o M. A. in Psychology
  - o B. A. in Philosophy

Permission to start B. A. in Performing Arts: Music and B. A. in Performing Arts: Dance was denied by the University of Mumbai. NCC as an elective course with credits will start from next academic year. As suggested, GIS is embedded in Geography PG program.

- 4. A total amount of Rs. 1.90 Lakhs was spent in this academic year towards awards and fellowships for students having achievements in sports, NCC, NSS and cultural activities. Rs. 54,500/- were spent towards awards for rank holder in different courses.
  - a. In the current academic year, the Krantijyoti Savitribai Phule Award for women achievers in different fields were given to-
  - Karmaveer Bhaurao Patil Award and Sau. Laxmibai Bhaurao Patil Award for commendable social work will be given from the next academic year i.e. 2019-20.
- 5. Internal Academic Monitoring Committee monitors internal evaluation pattern of examination of each department.
- 6. The fees will be raised for all courses by 10% from next academic year.

- 7. As per the suggestion in the previous meeting, comparative statement for current and previous year budgets were displayed in the Finance Committee Meeting.
- 8. A Parent Teacher Meeting will be conducted in the month of April to communicate changes in fee structure and curricula etc. Also, all the parents will be digitally informed about the changes.
- 9. Notional hours are indicated in the curricula.
