

# **Business:**

The meeting began with a warm welcome of the members of Board of Studies. Ms. Anita More Head of Department of Food Technology introduced the members of the Core Team of BOS to the faculty members of the department of Food Technology.

# Motion 1:Presentation of Theory Syllabus designed for B.Voc. Program in Food Technology (Course: FY, SY and TY B.Voc.) before the Board of Studies (Food Technology) for approval. And POS, COS of the syllabus.

Discussion: For B.Voc Semester 1 to 6, one paper was presented and also the POS, COs at a time and discussions were followed immediately after.

The following suggestions were made after presenting syllabus.

- 1. UGFT 105 Bakery Technology: In Unit III; fermented biscuits should be added as it's a novel bakery product and upcoming trend.
- 2. UGFT 105 Bakery Technology: In Unit IV; additives, emulsifiers, preservatives, leavening agents which are used in bread manufacturing should be added.
- 3. UGFT 106 Confectionery Technology: In Unit III; introduction of cocoa beans, cocoa powder, pulverization, fermentation, manufacturing of chocolates, conching of chocolate should be also be included.
- 4. UGFT 207 Food QA and QC: In Unit II; laws like Food Safety and Standards Act 2006, AGMARK, BIS, PFA, FPO, MMPO, MPO should be omitted as it is too much in details for second semester and also these laws are covered later on in the Third Year.

Auditing agencies, audit, auditor, quality manager these points should be added as these are the ones responsible for the entire quality management.

- 5. UGFT 207 Food QA and QC: In Unit IV; the entire unit should be changed. The title of the unit should be Food Quality Management Agencies in which, BRC, FSSC 22000, ISO 22000, TUV should be covered.
- 6. There will be no changes in POS COS .
