Discussion:

Hon.I/c Principal Dr. Shubhada Nayak informed to committee about implementation of CBCS pattern from the current academic year. She also informed about introduction of more electives for different UG and PG Programs resulted in increase in operating as well as fixed expenses. She presented the status of revenue generated and expenditure incurred in the last three financial years showing the deficit in Income and expenditure Statement. She requested committee for suggesting the way to adjust the additional expenditure and expressed her opinion about revision of fees from the next academic year.

Hon.I/c Principal Dr. Shubhada Nayak proposed 10% increase in Tuition fees for Under Graduate Programs -B.Com.[Banking and Insurance], B.Voc. Food Tech., B.A., B.Com. B.Sc. Non-Grant Divisions, Post Graduate Programs- M. Com, M.A. [English, Geography, Economics], M.Sc. [Mathematics, Physics, Bio -Analytical Sciences, Computer Science, Information Tech., Data Science], M.Sc. by Research, Ph.D. Programs. 15% increase in Tuition fees for under graduate program B. Sc.in Bio Technology and B.Sc. in Computer Science. 20% increase in Tuition fees for Undergraduate Self-Finance programmes B.Com.[Accounting and Finance, BMS, B.Sc. Information Tech., Post Graduate Programs M.A. in Psychology, M.Sc. in Microbiology and Chemistry.

She also proposed credit course fees Rs. 1000/ for second year classes for new elective courses and 10% increase in institutional other charges fees for all classes.

She informed about the change in evaluation system which resulted in increase in examination department expenditure. She proposed 5% increase in Examination Fees for UG and PG classes. Mr.C.D. Bhosale presented the table showing the existing fee and proposed fee.
