**HAPPYHARMONY, at A-604 Dwarka CHS, Sector 14, Koparkhairne, Navi Mumbai 400709, Proprietor- Dr.PALLAVI INDULKAR**

AND

**Karmaveer Bhaurao Patil College, Vashi Sector 15 A, Vashi, Navi Mumbai Dist.Thane-400703, hereinafter known as the "Resource Partner", represented by**

HOD of Microbiology Department.: Dr. Keshav Shinde

Associate Professor & Coordinator: Ms. Dhanashri Pachhade

1. As per the agreement, **HAPPYHARMONY (Delivery Partner)** herein confirms that it shall provide the necessary training on "**CAMPUS TO CORPORATE**" course to the bona fide students of **Karmaveer Bhaurao Patil College (Resource Partner)** herein agreed that such teaching and training as aforesaid mentioned shall be provided only for the fulfillment of the criteria of minimum number of students as agreed by the two parties.
2. The Delivery Partner agrees to provide the entire training on "**CAMPUS TO CORPORATE**" online via ZOOM online application.
3. This agreement must be signed only by the parties as detailed in clause 1.
4. The tenure of the contract would be from **09<sup>th</sup> August 2021 to 2<sup>nd</sup> September 2021** subject to the fulfillment of the conditions of this agreement, by the Resource Partner and to the satisfaction of the Delivery Partner.
5. Resource Partner would allocate appropriate time slots as agreed by the two parties before or after the academic schedule for the training programs offered by the Delivery Partner.
6. Training Duration: The Period of the Training would be for the prescribed number of 30hrs. and there would be minimum 30 and maximum 40 student per batch.
7. Fees

The Fees as Mentioned above is all inclusive.

All payments towards fees shall be made in the name of -

**“PALLAVI INDULKAR”.**

12. The fees as mentioned above are only for the specified period in the agreement.
13. The certificates of completion of the training program titled – **“CAMPUS TO CORPORATE”** to the enrolled students will be issued on successful completion of the training & evaluation process by **HAPPYHARMONY**.
14. Delivery Partner may offer from time to time other professional training programs to the students or teachers based on industry requirements and as per the demand from the college/students.
15. A minimum lead time of 5-10 days will be required to start the training from the date of signing the MOU.
16. Once the agreement is signed & the registration process starts, college will have to release the purchase order for the same within two days of signing of the agreement. In case of any dispute or differences whatsoever arising between the parties out of or relating to the construction, meaning, scope, operation or effect of this contract or the Validity or the breach there of shall be settled by arbitration in accordance with the Rules of Arbitration of the Indian Court of Arbitration and the award made in pursuance thereof shall be binding on the parties. “However the court of jurisdiction would be in Mumbai shall be binding on the parties.
17. For students those are irregular in the program trainings/ projects, no separate class (s)/training shall be conducted.
18. In case, if the student after getting himself/herself registered doesn't turn up for the training then the registration amount/fees for the same will not be refunded back.
19. Once the agreement is signed between Resource Partner & Delivery Partner, the same cannot be terminated for at least six months from the signing of agreement.
20. The Resources Partner should verify all the details and fully satisfy them before entering in to the agreement as once the agreement is signed the same cannot be terminated before expiry of the same.
