As and when required, the KBP College shall allow Popat Barikrao Chalak, Proprietor of Rajpal Hospital, koperkhairane, to conduct on-campus/ of-campus interviews of college students for placement. College would share training resources like library research section, laboratory manuals, and research journals at no extra cost.

4. Duration and Termination:

This agreement will take effect from the date of its signing and shall be valid for an unlimited **period** from that date unless sooner terminated.

This collaborative agreement may be amended, renewed and terminated by mutual written agreement of the two parties at any time.

5. Decision making structure and authority:

Both participating organizations will each identify one person within their own organization to serve on the collaboration committee for the collaborative work. Each member of the collaboration committee will be authorised to represent their organization in joint collaborative decision making. Each collaborative organization will be responsible for ensuring that the person granted authority to represent their organization is kept informed regarding the operation of the collaboration and the identification of the issues for joint discussion. Each member of the collaboration committee will keep their organization informed of collaborative progress and actively seek feedback regarding the collaboration from within their organization.
