Since there is no sanction vacant 01 post of Assistant Registrar (Level 10 or PB-3, GP of Rs. 5400/-) and 01 post of Medical Officer (Level 10 or PB-3, GP of Rs. 5400/-), this is to propose that:

- 1) The sanctioned vacant post **01 post of SAS Officer** (Level 10 or PB-3 + GP of Rs. 5400/-) be converted / re-appropriated to **01 post of Assistant Registrar (Level 10 or PB-3 + GP of Rs. 5400/-)** and
