The appointment of the above candidates will be governed by the under-mentioned conditions:

1. Appointed person will be under probation for a period of **1 (one) year** as stipulated in the NITs Statutes, after which his/her service may be confirmed. The probation period is liable to be extended, depending on the performance.
2. Pay of the appointed person will be fixed as per the existing provisions of Schedule-E of the First Statutes of National Institutes of Technology (Amendment) Statutes, 2017. The service condition will be governed, as per NITSER Act and the Statutes of NITs, and as amended from time to time.
3. The appointment is subject to the general terms and conditions of service applicable to the employees of NIT Mizoram, as in force under NITSER Act 2007 and the Statutes of NITs, and as amended from time to time, by the Government of India.
4. Appointed person will report to the Establishment Section for verification of all original Certificates/ Documents. The valid Caste/Tribe/Community Certificates (if applicable), in original, shall be produced for verification at the time of joining.
5. Appointed person will be governed by the **National Pension System (NPS)** of the Government of India which is in effect from 2004.
6. Appointed person is required to produce **Relieving Certificate** from the previous employer at the time of joining, **if employed**.
7. Upon joining NIT Mizoram, appointed person is required to produce the Medical Certificate of Fitness issued by a competent authority i.e a Standing Medical Board.
8. Appointed person is required to produce Character and Antecedents Verification Report from Police authorities of his/her domicile.
9. Appointed person shall perform duties as may be assigned by the competent authority of the Institute, from time to time.

10. Appointed person is informed to join his/her duty **within 30 days from the issue of this letter.**




